# **Sponsoring ECI's 2024 IMPACT EVENT**

#### What will make IMPACT unique?

- Focus on assessment & benchmarking: The event this year will have a heavy focus on program assessment, benchmarking, and providing opportunities for our participants to connect with vendors and consultants who can address their areas of need that are identified throughout the event. Each participant will complete ECI's Program Assessment (based on our Framework for Excellence) prior to the event. Throughout the conference, participants will have multiple opportunities to compare results with peers and to consult with sponsors about their needs.
- Introduction of Program Certification: At the event, ECI will be launching a new program certification, based on our longstanding Framework for Excellence. Throughout the event we will be gathering input from attendees about the criteria and process for program certification. We welcome the input of our sponsors in those discussions; you will get an inside look into the new certification standard.
- Select Group of Sponsors: Given the focus and the venue for the
  event, ECI is limiting sponsorships to a small number of organizations
  that we are confident can help address the needs of our participants.
